General information

What is the aim of the survey?

The goal of the German Standardization Panel is to record the standardization strategies of German companies. The survey serves as a source of information for future decisions by both the standard-setting organizations and the stakeholders active in standardization, and by companies that were not yet involved in standardization.

The German Standardization Panel also intends to collect long-term data, which will be available for standardization research. The annual survey always begins on October 14, World Standards Day.

The German Standardization Panel is conducted by the department of Innovation Economics at the Technical University of Berlin on behalf of DIN (German Institute for Standardization) and DKE (German Commission for Electrical Engineering Electronics and Information Technologies). It is under the patronage of the German Federal Ministry of Economics and Climate Action (BMWK).

Structure of the questionnaire

The questionnaire is structured along the following major themes:

- **Importance of standards:** Questions on the importance, use, and implementation of standards, as well as on other aspects of technical rules.
- **Standardization activities:** Questions about the use of resources for standards and Standardization activities

2. General significance of standards and specifications

Explanation of the standard types:

The following section contains questions about the relevance, the use, and the implementation of norms and standards, as well as other aspects of technical rules. A distinction is made between formal standards, technical rules or specifications, consortia standards, de-facto standards and company standards.

- **Formal standards** are developed in the committees of the national standardisation bodies/ national SDO (standard development organisations) in full consensus of all interested parties. Examples at international level are ISO/IEC or EN standards.
- Technical Specifications (e.g., AFNOR Cahiers Techniques, CWA, DIN SPEC, or UNI/PdR) are developed by experts in formal standardisation organisations (e.g., AFNOR, BSI, or DIN), but, like technical rules, are not adopted in full consensus decisions (by associations such as CNI, FEANI, VDI, VDMA, or VDE). Other examples are IWA, CWA, TS, TRs or PAS.
- Informal **consortia standards** are developed by a select group of companies in consortia (and thus outside the formal standardisation organisations).
- **De-facto standards** are **not** developed by consortia, but result from the demand behavior in the market (e.g., Microsoft Office, Word, PDF).
- **Internal company standards** are developed within a company and are used company-specifically by the company itself or by cooperating companies (e.g., suppliers).
- External company standards are company standards originally developed by other companies (e.g., purchasers / buyers) and then introduced internally.


