Welcome to the German Standardisation Panel 2023 Survey!

General information

What is the aim of the survey?

The goal of the German Standardisation Panel is to record the standardisation strategies of German companies. The survey serves as a source of information for future decisions by both the standard-setting organisations and the stakeholders active in standardisation and by companies that were not yet involved in standardisation.

The German Standardisation Panel also intends to collect long-term data, which will be available for standardisation research. The annual survey always begins on October 14, World Standards Day. This year, the first survey round of the European Standardisation Panel is taking place in parallel.

The German Standardisation Panel is conducted by the department of Innovation Economics at the Technical University of Berlin on behalf of DIN (German Institute for Standardisation) and DKE (German Commission for Electrical Engineering Electronics and Information Technologies). It is under the patronage of the German Federal Ministry of Economics and Climate Action (BMWK).

Structure of the questionnaire

This year's questionnaire is structured as follows:

- **Importance of standards:** Questions on the importance, use, and implementation of standards, as well as on other aspects of technical rules.
- **Standardisation activities:** Questions about the use of resources for standards and standardisation activities.
- **General information:** Questions about general characteristics of your organisation, including, but not limited to, information that can be found in your annual report.
- **Influence of research on standardisation:** Questions about the role of research for standards development.
- **Importance of European Standardisation**

After completing the survey, the results will become available exclusively to the survey participants. Later, after we compared all your companies that responded to our survey, we organise a research report that will be openly available to a broader audience.

1. Significance of standards and

specifications

Explanation of the standard types:

The following section contains questions about the relevance, the use and the implementation of norms and standards, as well as other aspects of technical rules. A distinction is made between formal standards, technical rules or specifications, consortia standards, de-facto standards and company standards.

- **Formal standards** are developed in the committees of the DIN e.V. or DKE in full consensus of all interested parties.
- **Specifications** (e.g. DIN SPEC) are developed by experts in formal standardisation organisations (e.g. DIN e.V. or DKE), but, like technical rules, are **not** adopted in full consensus decisions (by associations such as VDI, VDMA, VDE).
- Informal **consortia standards** are developed by a select group of companies in consortia (and thus outside the formal standardisation organisations).
- **De-facto standards** are **not** developed by consortia, but result from the demand behavior in the market (e.g. Microsoft Windows).
- **Internal company standards** are developed within a company and are used company-specifically by the company itself or by cooperating companies (e.g. suppliers).
- **External company standards** are company standards originally developed by other companies (e.g. purchasers / buyers) and then introduced internally.
